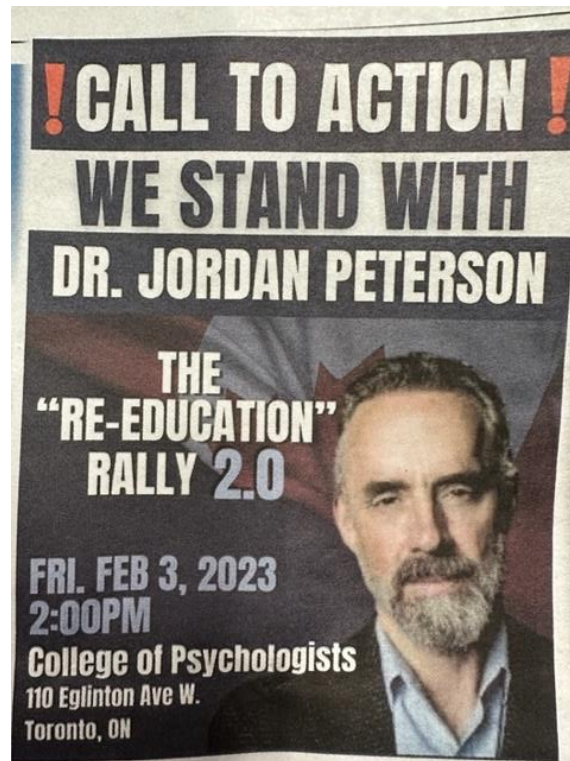

“I was told specifically by somebody: Your story is just an anecdote... So it’s really irresponsible for you to talk about it because you could stop

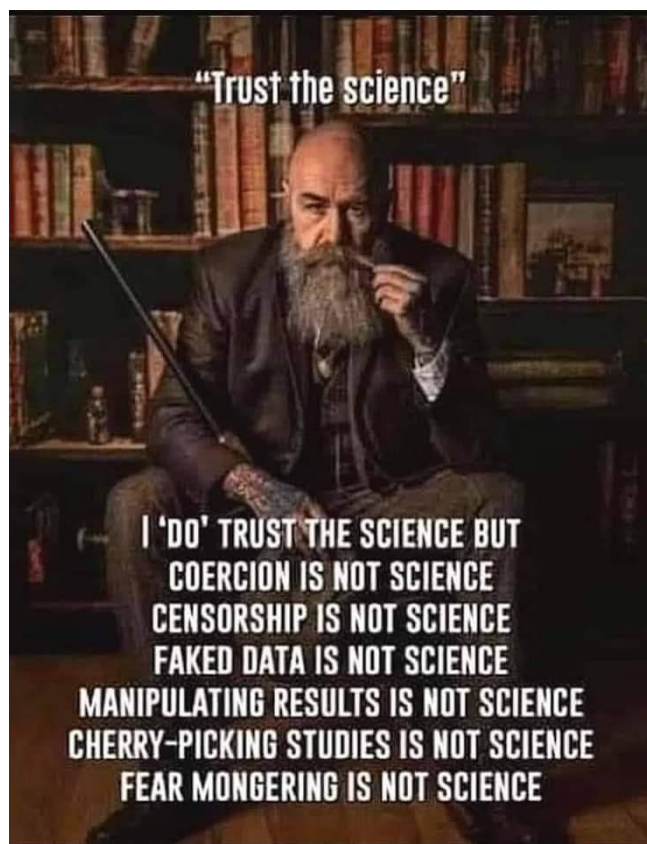

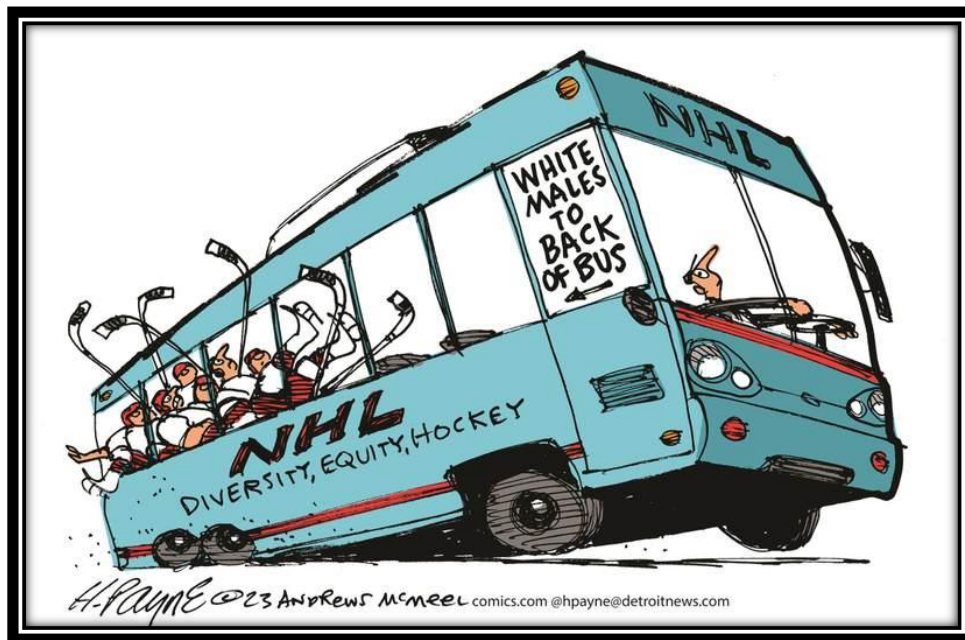
